

**Purpose of Modification:**

The purpose of this modification is to update Contract Section B, *Supplies or Services and Prices/Costs*, with incremental funding provided under Purchase Requisition No. 12EM002787. Incremental funding provided herein is as follows:

This modification also de-obligates funding to Inter-Entity Work Order (IEWO) No. M0IDV00061. Work performed under the said IEWO has been completed and the de-obligation of funds provided herein is the result of the close-out of the IEWO and the de-obligation of uncosted funding.

**Description of Modification:**

- The table in Section B, *Supplies or Services and Prices/Costs*, Contract Section B.2 *Obligation and Availability of Funds and Contract Value*, paragraph (a) is revised as follows:
  - The total amount of funds obligated to budgetary control point 1111245 is increased by \$50,000,000.00 from \$924,670,799.00 to \$974,670,799.00.
  - The total amount of funds obligated to budgetary control point 1111241 is increased by \$46,000,000.00 from \$298,530,590.00 to \$344,530,590.00.
  - The total amount of funds obligated to budgetary control point 1111243 is increased by \$24,000,000.00 from \$83,000,000.00 to \$107,000,000.00.
  - The total amount of funds obligated to budgetary control point 1111242 is increased by \$20,000,000.00 from \$132,500,000.00 to \$152,500,000.00.
  - The total amount of funds obligated to budgetary control point 1111186 is increased by \$15,679.66 from \$559,559,983.95 to \$559,575,663.61.
  - The total funding obligated to the Budgetary Control Points for the WTP Project is increased by \$140,015,679.66 from \$7,507,848,630.59 to \$7,647,864,310.25.

- The total funding obligated to the Budgetary Control Points, including Program Direction funding, is increased from \$7,509,328,630.59 to \$7,649,344,310.25.
- The total amount of funds obligated to IEWO No. M0IDV0061 is decreased by \$8,722.40 from \$30,000.00 to \$21,277.60. This funding is decreased under Amendment No. 1 dated June 18, 2012.
- The total funding obligated to IEWO is decreased from \$77,697,517.87 to \$77,688,795.47.
- The total funding for budgetary control points for the WTP Project is increased from \$7,587,026,148.46 to \$7,727,033,105.72.
