
**14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)**

The purpose of this modification is to issue a Change Order to increase the Not-to-Exceed (NTE) for Washington River Protection Solutions, LLC (WRPS) to continue with activities related to the Comprehensive Vapor Action Plan (CVAP) Key Performance Parameters (KPP) Implementation scope of work (CP-17-009). The NTE is being increased by \$14.1M for a revised NTE value from \$25M to \$39.1M.

In accordance with Clause I-103A, FAR 52.243-6, Change Order Accounting (APRIL 1984), WRPS shall continue to use a separate charge account to segregate costs associated with this change order until the change is definitized.
