 The purpose of this Change Order is to issue a Not-to-Exceed (NTE) in the amount of \$64,000.00 for Washington River Protection Solutions LLC (WRPS) to complete the proposal process for the 222-SA Cold Laboratory construction. The planned schedule to negotiate this scope of work is December 30, 2016, and definitize the change via modification by January 13, 2017.
