14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to increase the Not to Exceed (NTE) value issued in Change Order modification 314 and 379 for WRPS to continue work on the C-105 Third Technology. As a result of this modification, the current NTE value of \$16M is increased by \$4M, for a revised NTE value of \$20M. WRPS shall continue this work in accordance with the work scope provided in modification 314 and 379.

In accordance with Clause I-103A, FAR 52.243-6, Change Order Accounting (APRIL, 1984), WRPS shall continue to segregate costs associated with the effort under the C-105 Third Technology effort into the separate charge account created as a result of modification 314 until the change is definitized. The definitization schedule for Change Order modification 314 is as follows:
