
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to issue a Change Order to increase the Not-to-Exceed (NTE) for Washington River Protection Solutions, LLC (WRPS) to continue with activities related to AY-102 Phase 3 scope of work (CP-16-020) transmitted in ORP letter 16-TF-0134, dated December 21, 2016. The NTE is being increased by \$1,250,000 for a revised NTE value from \$2,000,000 to \$3,250,000.

In accordance with Clause I-103A, FAR 52.243-6, Change Order Accounting (APRIL 1984), WRPS shall continue to use a separate charge account to segregate costs associated with this change order until the change is definitized.
