The purpose of this modification is to issue a Change Order to increase two (2) Not-to-Exceeds (NTEs) for Washington River Protection Solutions LLC (WRPS) to continue with activities related to the below scopes of work.

1. Comprehensive Vapor Action Plan Key Performance Parameters Implementation Actions. The NTE is being increased by \$8.2M for a revised NTE value from \$39.1M to \$47.3.

2. SX Barrier Expansion Design. The NTE is being increased by \$100K for a revised NTE value from \$100K to \$200K.
