
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to issue a Change Order to increase the Not-to-Exceed (NTE) for Washington River Protection Solutions, LLC (WRPS) to continue with activities related to the Package Specific-Safety Document for Immobilized Low-Activity Waste Container scope of work (CP-17-006) transmitted in ORP letter 17-WSC-0004, dated February 3, 2017. The NTE is being increased by \$150,000 for a revised NTE value from \$200,000 to \$350,000.

In accordance with Clause I-103A, FAR 52.243-6, Change Order Accounting (APRIL 1984), WRPS shall continue to use a separate charge account to segregate costs associated with this change order until the change is definitized.
