
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this Change Order is to issue a Not to Exceed (NTE) in the amount of \$200,000 for Washington River Protection Solutions LLC (WRPS) to commence work on the Package-Specific Safety Document for the Immobilized Low-Activity Waste Container. The request for proposal for this new scope of work was requested via ORP letter 17-WSC-0004, dated February 3, 2017.

In accordance with Clause I-103A, FAR 52.243-6, Change Order Accounting (APRIL, 1984), WRPS continue to use a separate charge account to segregate costs associated with this Change Order until the change is definitized. The estimated definitization schedule for this Change Order is as follows:
