The purpose of this modification is to issue a Change Order to increase the Not-to-Exceed (NTE) by \$150,000 for Washington River Protection Solutions, LLC (WRPS) to continue working on the AY-102 Phases 3 & 4 scope of work transmitted in ORP letters 16-TF-0134, dated December 21, 2016 and 17-TF-0077, dated October 10, 2017. The revised NTE amount is changed from \$3,250,000 to \$3,400,000. In accordance with Clause I-103A, FAR 52.243-6, Change Order Accounting (APRIL 1984), WRPS shall continue to use a separate charge account to segregate costs associated with this change order until the change is definitized.
